

## **CODE OF CONDUCT and INDEMNITY**

## PLAYERS, COACH AND OFFICIAL CODE OF CONDUCT

This code of conduct shall apply to all players. Any breach thereof shall be subject to disciplinary action by the Casey Hockey Club and may result in disciplinary action or expulsion from the club as determined by the committee.

- 1. I fully agree to play under the jurisdiction of Hockey Victoria as a registered player of Casey Hockey Club.
- 2. I will not engage in the use of crude, foul or abusive language that may be deemed offensive or engage in any conduct detrimental to the image of the game or the Casey Hockey Club when on or off the field.
- 3. I will refrain from arguing with the referees regarding decisions they make.
- 4. I will treat participants, officials and spectators with respect.
- 5. I will play by the laws of the game.
- 6. I will cooperate with my coach, teammates, referees and officials.
- 7. I will not use any banned substance or drugs of dependence throughout my involvement with the Casey Hockey Club.
- 8. I will not consume or be under the influence of alcohol during a game.
- 9. I will display good sportsmanship at all times.

## PARENTS CODE OF CONDUCT

This code of conduct shall apply to parents and guardians. Any breach thereof shall be subject to disciplinary action by the Casey Hockey Club and may result in disciplinary action or expulsion from the club as determined by the committee.

- 1. Remember children play sport for their enjoyment, not yours,
- 2. Encourage children to participate, do not force them.
- 3. Focus on the child's efforts and performance rather than winning or losing.
- 4. Encourage children to always participate according to the rules.
- 5. Never ridicule or yell at a child for making a mistake or losing a game.
- 6. Remember children learn best by example. Applaud good play by all teams.
- 7. Support all efforts to remove verbal and physical abuse from sporting activities.
- 8. Respect officials' decisions and teach children to do likewise.
- 9. Show appreciation of coaches, officials and administrators. Without them your child could not participate.
- 10. Respect the facilities that are being used.

## **PLAYER INDEMNITY**

Exclusion of Liability for Damage to Player's Person or Property and Indemnity as a result of non wearing of mouthguard – Casey Cannons Hockey Club.

I hereby accept there is an inherent and foreseeable risk of receiving a knock to the mouth or a ball striking my mouth in undertaking hockey activities. I acknowledge these risks are why Casey Hockey Club encourages all players to wear mouthguards and shin pads.

I hereby agree that Casey Hockey Club, its Committee, Umpires, Technical Officials and other volunteers shall not be nor be deemed responsible or liable for any injury, illness or other mishap to me or my property sustained in any match, competition, practice, training or function of whatsoever nature held during the period of this Registration as a result of my participating in the activity without wearing a mouthguard or shin guards.

I hereby indemnify and will at all times hereafter well and sufficiently indemnify and keep fully indemnified Casey Hockey Club, its Committee, Umpires, Technical Officials and other volunteers from and against all actions, claims, demands, costs and expenses whatsoever arising out of any such injury, illness or mishap to me or my property arising from my participating in the activity without wearing a mouthguard or shin guards.
