Discussion was also held as to whether there should be a junior section, which is a separate committee. No conclusion was made in relation to the discussion

The next meeting for the new Committee was to be held on the 30th November 2005

General Business

Tracey Brown brought up the issue that in relation to juniors there should be a Match secretary who looks at the games in relation to coaching/umpiring. Perhaps there should be a Hockey Development Sub Group as the Committee only looks at the operations of the Club and there should be someone who keeps an eye on the way players are going.

There should be a booklet which states our policies and looking at our processes in relation to playing. I.e. making sure that players are assisted to their true potential.

We need to rattle the cage in relation to Hockey Vic and promotion of the Club. Need to focus on hockey within the club.

It was mentioned that in relation to the operations of how Hockey Vic works then the Brown family are probably the only members of the Club, which have that knowledge. Tracey indicated that she would be happy to assist sub committee in Hockey Operations.

Tracey also mentioned that the PE Teacher from Berwick Secondary College was interested in joining the Club with a team.

Kevin Moore raised the issue that it would be good to be able to video games and perhaps we could buy a video camera.

Discussion was raised on the issue that the Club needs to look at how we deal with 2 teams within a section. It has become an issue in previous years where the A teams have taken players from the B team which has then meant that the B team cannot field a full team and appear to continually lose. Parents unhappy that their child is being placed in a situation where they are not able to show full potential. Perhaps we need to look at how the teams are made up of players. Need to be mindful of the opportunity to provide best level for all players. It may be a good idea to provide a mentoring program for the second teams. It can happen that the next year those second team players will have to play in the A team and it is important that they do not feel overwhelmed. Suggested that the two teams should practice together as Much as possible.

Fundraising: Discussion was held in relation to the fundraising forms sent out in the last month. It was noted that the date for payment had not been put on the form. It was decided that the fees could be held at 2005 prices if they were paid before the 31.12.2005. It was also mentioned that the Bricks and Shares etc are over and above the fees. There were also concerns about our ability to fund the new building, as we are not able to use the Sinking Fund. However Ian Shiells had investigated the Australian Sports Foundation, which provides the same sort of tax deductibility and which also, manages the funds. Registration fee is \$275.00.

It was mentioned that by speaking to Frances Moore and Brian Andrews we might be able to approach past members to donate monies for a brick etc. Do a mass mail out.

It was also discussed that perhaps a sausage sizzle at Bunning's Fountain Gate may be an answer to some fundraising as it can raise \$1200 in a day.
